

RESOLUTION NO. 15 - 33

**RENAMING PORTIONS OF HOSPITALITY LANE TO BRINY LANE  
IN THE SEASIDE VILLAGE PLANNED COMMERCIAL DEVELOPMENT**

WHEREAS, by Resolution No. 14-10 adopted on April 1, 2014 the County Commissioners of Worcester County, Maryland (County) established the names of several approved private roads in the Seaside Village Residential Planned Community and Planned Commercial Development located to the north of US Route 50 and east of Golf Course Road in Worcester County, Maryland; and

WHEREAS, pursuant to a request from Hugh Cropper, IV, Attorney, on behalf of Abel Holdings, LLC, owner of Lot 1 in the Seaside Village Commercial Condominiums, the County renamed "Briny Lane" as "Hospitality Lane" in the Seaside Village Planned Commercial Development by Resolution No. 15-25 adopted on July 21, 2015; and

WHEREAS, the County has now received a request from Mark Spencer Cropper, Attorney, on behalf of his client, Shane Pollin of The Duffie Companies, and agreed to by Ben Seidel of Resort Hospitality Group, requesting that portions of "Hospitality Lane" be renamed "Briny Lane" in the Seaside Village Planned Commercial Development; and


WHEREAS, in accordance with the provisions of § Section PS 6-101 (Provisions for naming of private lanes) of the Public Safety Article of the Code of Public Local Laws of Worcester County, Maryland, the County Commissioners reviewed the request at their meeting of November 3, 2015 and determined that the proposed renaming of portions of Hospitality Lane to Briny Lane is acceptable.

NOW, THEREFORE, BE IT RESOLVED by the County Commissioners of Worcester County, Maryland that the request of Mark Spencer Cropper, Attorney, on behalf of The Duffie Companies to rename portions of "Hospitality Lane" to "Briny Lane" in the Seaside Village Planned Commercial Development as described herein is hereby approved.

AND, BE IT FURTHER RESOLVED that this Resolution shall take effect upon its passage.


